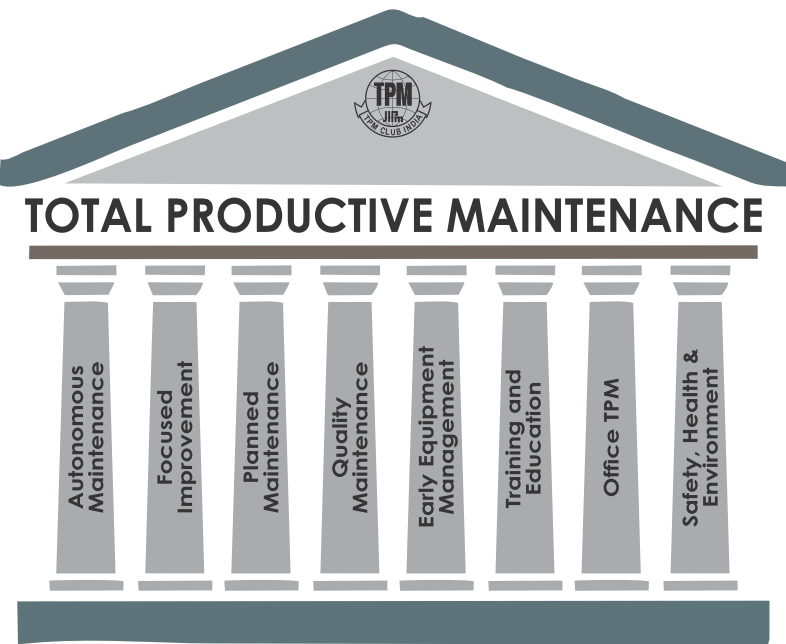

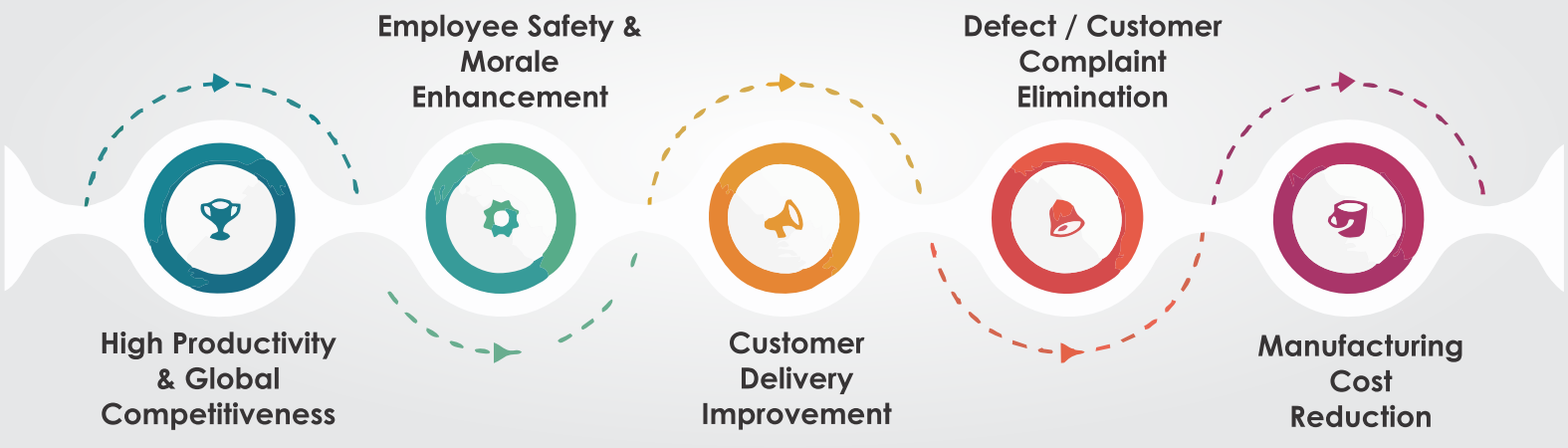


TPM - maintaining and improving the integrity of production, safety and quality systems through the machines, equipment, processes, and employees that add business value to an organization

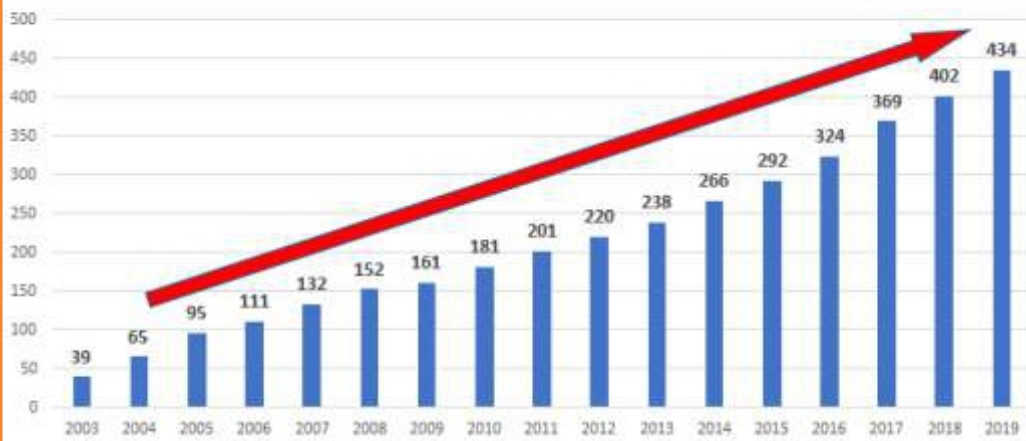
