MUDA

Non-value work or operations.
It includes 7 types of Muda

- MUDA of Overproduction
- MUDA of Stock
- MUDA of Conveyance (Transport)
- MUDA of Waiting
- MUDA of Operation Itself
- MUDA of Movement of Worker
- MUDA of Production of Inferior goods



MURA

Working under uncontrolled fluctuations, unevenness or imbalance. Eliminating unevenness or irregularities in the production line among different Man/ Machine or process. Creating JIT concept.



MURI

Means working in unnatural conditions, overburden, working under strain. It can be for both Man or Machine. A person, who is working in extreme conditions due to excess noise, temperature, fumes etc., experience Muri / burden. Muri on equipment means machines that are operating over its safe limits or set performance limits. Overloading, abuse, poor maintenance etc., causes Muri.

- Topics - not as per annexure 1
- The Kaizen topic and the presentation topic should be same
- Kaizen theme and the content of Kaizen are different
- Inadequate information in Kaizen sheet
- Standard Kaizen sheet format - not followed
